## Parade Entry Form and Information

South Jordan City invites you to join us for our annual Country Fest celebration. This year our theme is "Find Your So Jo Spirit". As always, the parade is a favorite of residents and participants alike. We invite you to join with us, as a participant in the parade, on the 19<sup>th</sup> of June, at 9:00 a.m. Please take a minute to read the following information, complete the attached form and submit it as soon as possible. **\* Please note route and staging location changes!**

- ✓ All applications are due on or before June 1, 2010. Approved entries will receive a confirmation soon after.
  - By June 14<sup>th</sup> entries will receive a parade number, staging time and a map for lineup and staging.
- ✓ **The parade will begin at 9:00 AM sharp. The earliest staging time will begin at 7:15 AM, in the City Hall (1600 W Towne Center Drive) East Parking lot. All entries must enter from Beckstead Lane as Redwood Road will be closed. All entries must check-in and proceed to their pre-assigned staging location. Watch for signs along Beckstead for check-in entrances. All entries must be in place by 8:30 AM.**
  - **The Parade Route will begin at City Hall run down Towne Center Drive then proceed South on Redwood Road and then west on 10960 South (approximately 1 mile from 10400 South). Entries will unload at the north City Park parking lot on City Park Road and exit out of the park to 2200 W.**
- ✓ Water Guns and/or Balloons are not permitted in the parade.
- ✓ Candy may not be thrown; an 'under-hand' toss is acceptable.
- ✓ All Equestrian entries must provide their own pooper – scooper.
- ✓ An entry campaigning for political office must be an officially filed candidate.
- ✓ As an applicant you shall indemnify, defend and hold harmless, the City of South Jordan, its elected and appointed officials, officers, agents, employees, contractors and volunteers from any liability for injury, loss, claims or damages which may hereafter be asserted arising out of the negligent operations, acts, or omissions said applicant, its officers, agents, contractors and employees during the performance of this event.
- ✓ The City of South Jordan and the parade committee will have sole discretion to prohibit any entry that they deem controversial, unlawful, or is considered to be inconsistent with the City of South Jordan and Country Fest Parade.
