## PARADE ENTRY FORM & INFORMATION

June 16, 2012, 9:00 AM

South Jordan City welcomes you to our annual Country Fest celebration. Our parade is a favorite among participant and resident. South Jordan is excited you're interested in participating with us June 16, at 9:00 a.m. Please take a moment to read the following information, complete the attached form, and submit before June 5 to avoid the **\$25 late fee**.

- ✓ All applications are due on or before June 5, 2012. Any forms submitted after this date is subject to a \$25 late fee. You can expect to receive confirmation your form has been accepted.
  - By June 12 entries will receive a parade number, staging time and maps for route, lineup, and staging. Please adhere to your staging time. All entry participants must arrive at your assigned time.
- ✓ The parade will begin at 9:00 am *sharp*. The earliest staging time will begin at 7:15 am, in the City Hall East Parking lot (1600 W Towne Center Dr). All entries must enter from Beckstead Lane as Redwood Road will be closed. All entries must check-in and proceed to their pre-assigned staging location without delay. Watch for signs along Beckstead for your check-in entrances. All entries must be in place by 8:30 am.
  - The Parade Route will begin at City Hall run west on Towne Center Drive, south on Redwood Road, and finally west on 10960 South (apox. 1 mile from 10400 South). Entries may unload at the north City Park parking lot on City Park Road and exit out of the park to 2200 W.
  - No entries may remain in the park.
- ✓ Water Guns and/or Balloons are not permitted in the parade.
- ✓ Candy may not be thrown; an 'under-hand' toss is acceptable.
- ✓ All Equestrian entries must provide their own pooper – scooper.
- ✓ An entry campaigning for political office – limited to first 10 applicants.
- ✓ By submitting your application you shall indemnify, defend and hold harmless, the City of South Jordan, its elected and appointed officials, officers, agents, employees, contractors and volunteers from any liability for injury, loss, claims or damages which may hereafter be asserted arising out of the negligent operations, acts, or omissions said applicant, its officers, agents, contractors and employees during the performance of this event.
- ✓ The City of South Jordan and the parade committee will have sole discretion to prohibit any entry that they deem controversial, unlawful, or is considered to be inconsistent with the City of South Jordan and Country Fest Parade.
